Tax Collection

Updated 2nd tax delinquent notices and mailed to include new language according to the 2019 Legislation requirements. This added the following below: **As this is a notice and not the actual tax bill it was allowed to be added without resolution.** I called these phone numbers and they assist people with budgeting and making sure they are getting the appropriate exceptions if they qualify.

Pursuant to New York's Homeowner Protection Program (HOPP), every notice of unpaid taxes—including this second notice—must contain information about regional housing counseling agencies funded by HOPP.
